## Relief Begins with Compliance

While some osteoarthritis patients receive immediate pain relief from bracing, many must wear a brace several weeks to allow inflammation to subside. Early compliance is a crucial step in OA bracing therapy.

The prefabricated StepFree OA™ brace represents state-of-the-art in low-profile, comfortable bracing. The new semi-circumferential shells reduce bulk by more than 50%. In fact, this brace can be folded to store in a thin briefcase or purse when not in use. This revolutionary design also eliminates the tibial crest pain created by other braces. Soft suede liners extend beyond the shell borders to comfortably keep the brace in place over many hours of continual use.

### Patented Pain Reduction

The pain-reducing action of the StepFree OA brace is maximized at the terminal extension phase of gait, when knee surfaces are under load and most susceptible to wear. This patented design ensures that the tibial lever arm is positioned down the mid-medial or mid-lateral line of the tibia during the mid-phase of gait, providing optimal corrective forces.

## Ease of Use

Brace wearers have little patience for complicated fitting procedures. Obese patients may lack the flexibility to thread D-rings. Geriatric patients may not have the strength or dexterity to put on a large, heavy brace.

To address these concerns, we started with an ultra-lightweight design that's easy to handle. Elasticized upper and lower straps allow the patient to quickly secure the brace in place, while the rigid mid-straps maximize corrective forces at the knee. Side buckles with push-button release clips make it a snap to put on or remove the brace.

- Ultra-lightweight (13 oz. short medium; 15 oz. standard medium)
- High-strength 6061-T5 aluminum hinge with built-in tibial rotation mechanism
- Fiber-reinforced composite shells are strong and lightweight
- Ex-Clips provide 5, 10, 15, 20 or 25 degree extension stops
- Elasticized hook and loop straps (upper thigh and lower tibia) provide tension throughout gait
- Non-elasticized mid-straps maximize corrective forces
- Side buckles ease brace application and removal
- Soft suede liners for comfort and suspension
- Optional suspension wraps to contain excess soft tissue
- One size fits all/semi-circumferential shells eliminate complicated sizing
- Factory applied force setting of 4 degrees to accommodate most patients
- Available in platinum gold finish
